Administration

- ➤ Held a Leadership Team Meeting on September 27, 2023, with all the department heads to discuss the FY23-24 Budget management and accountability, performance evaluations, and updates from each department, and discussed 10 Attributes of Leadership.
- Continue to meet with various community stakeholders, local government executives, local businesses, and citizens.
- Continuing to review with the Human Resources Director the current organizational structure, processes, procedures, tangible and non-tangible benefits, programs, initiatives, and services.
- ➤ Completed the review of the final recommendations regarding the development moratorium Land use Map, Comprehensive Plan elements, and Zoning Ordinance.
- > Presented City Manager's FY23-24 Final Budget recommendation to City Council on September 5th and 18th. It was unanimously approved by City Council.
- City Manager attended his first-ever National Night out!
- ➤ The City Clerk and Community Engagement Director continue to work on the City's Website Upgrade.
- Met with a group of business owners in the Downtown on September 11, 2023.

Finance

- ➤ The three LGIP General Fund investment accounts earned approximately \$55k in interest this month, with an average interest rate of 5.19%. As of month 12, of 12, the City has earned \$460k+ in interest in FY22-23.
- Staff are continuously completing journal entries, receiving payments and various revenues, processing account payables, generating work orders for public works and public utilities, and responding to citizen inquiries daily.
- Monitoring FY22-23 Budget expenditures and revenues. The close of the current fiscal year is three days away.
- Staff have selected an accounting software company to update and improve the current accounting software.
- Staff are preparing for the FY22-23 Audit and closeout of FY22-23.

Fergus Crossing

 Bonding requirements and maintenance fee agreements have been met, new home construction in phase 1 will begin soon.

Wilkerson Place

o Construction continues, no damages to infrastructure.

Lake Caldwell

- Revised drawings were resubmitted to DHEC 9/25/2023 and all comments were addressed.
- o Notice of Intent from SCDHEC for grading activities has been granted.
- Awaiting General Construction permit from DHEC.

Liberty Street Waterline Extension

- Additional field surveying is being scheduled to gather additional information in the vicinity of the Highway 321 intersection.
- Permitting Documents are being prepared and water system design and reporting are being finalized. Coordination is ongoing with the City for flow information for the existing system so that calculations and the associated documents can be completed.

- The SCDOT core sample information has been assessed and impacts to the concrete subgrade has been minimized to the extent possible. The final design is being pushed to no later than 11/15/2023 because of the concrete road bed issues.
- Highway 321 concepts for connecting to the existing 12" waterline are being finalized and cost analysis is being performed to advise the City on options.
- The project is ahead of schedule for SCIIP.

Monterey Park

Construction in phases 1 & 2 continues with no damage to infrastructure.

Asbury Ridge

- Construction continues in phases 1 & 2.
- Phase 3 is awaiting final plat. A punch list of items was created earlier in the month and staff will be checking to see if those items were completed.
- o As of this report the punch list items requested have not been completed.

Lake Caroline Upper and Lower Dam

 Armstrong Glenn presented the city with a proposal for phase 2 Improvements based on the report given to the City in August which accompanies this report

Lincoln Rd. Sidewalk Project

- Field Survey and Topographical Survey are 100% complete.
- Subsurface Utility location is 100% complete.
- Designs were completed and sent to SCDOT and SCDHEC. SCDOT had very minor comments which were to provide the approval letter from SCDHEC and removing the high visibility crosswalk.
 Other comments if any are expected the first week in October.
- ESP will begin preparing and submitting a permit application to the US Army Corps of Engineers if required.
- ESP contacted us about the Headwall design detail for the project, it will need to be designed by a structural engineer. This was not included in the original scope of work. Staff has reached out to a 3rd party consultant to review the design and give an estimated probable cost.
- Aesthetic Concepts will be providing the design of the headwall to the City and ESP. This will save the project an estimated \$2000 to \$3000

Railroad Ave. Sidewalk Project

- Field survey work is complete except for utility locates. SC811 utility locator service has been delayed with Campco. Should be completed by the end of the week.
- A meeting is scheduled on October 5, 2023 to view the preliminary design of the sidewalk.

Fishing Creek WWTF

- Design is almost complete.
- Davis & Floyd has yet to receive comments from SCDHEC on the submitted design drawings.
- o Progress is being made on the electrical and mechanical drawings and specifications.
- Permitting began in early July, and awaiting comment (if any), assuming to receive a construction permit at or around 10/20/2023
- The project is ahead of schedule for SCIIP.

Water Treatment Plant Environmental Review & Remediation

 A final report was sent to the City on August 15th. The report includes the studies that were performed, Gap analysis, and Preliminary Cost Opinions. Based on the preliminary cost estimates, we will be moving forward with phase 2 and using Davis
 Floyd for the completion of the project.

Bellina Subdivision

- The first phase of land clearing and storm water protection is underway.
- Silt fencing and the approved construction entrance have been installed.
- BMP's and Stormwater Impoundments are currently under construction.
- Water and Sewer construction permits have been issued.

Brighton Springs

- Willingness and Capability has been issued for the proposed subdivision in June.
- Permitting for Land Disturbance, Stormwater construction, Water and Sewer construction has begun.

Pinckney Rd. PUD

- Willingness and Capability has been issued for the proposed project.
- All review comments were addressed and corrected.
- Permitting for Land Disturbance, Stormwater construction, Water and Sewer construction has begun.

McFarland Estates

- Permits for Land Disturbance, Stormwater construction, Water and Sewer construction have been issued.
- A pre-construction meeting was held on 8/31/2023 to go over pre and post development standards with the developer.
- Land Clearing in phase 1 continues with BMP's and Stormwater impoundments under construction as well.

Filbert Hwy/Larson Rd. light industrial

- All review comments have been addressed.
- o Staff received Water and Sewer Construction permit on July 19, 2023.
- Staff contacted ESP for scheduling of a pre-construction meeting.
