### What are Data Metrics?

A data metric is an aggregated calculation within a raw dataset. Operationally, a data metric becomes a data point that can be used to understand better what’s going on across the wider dataset and is used in businesses to track and understand business trends and impacts. Data analysts and scientists use data metrics to uncover valuable insights into patterns and trends that could impact critical business activities.

Key performance indicators (KPIs), benchmark metrics, net profit margin, monthly recurring revenue (MRR), and other business performance metrics are examples of different metrics. Data metrics might come from data analytics, or any other metric data related to a company’s performance. They are often used to optimize decision-making processes, meet business goals, and provide validation.

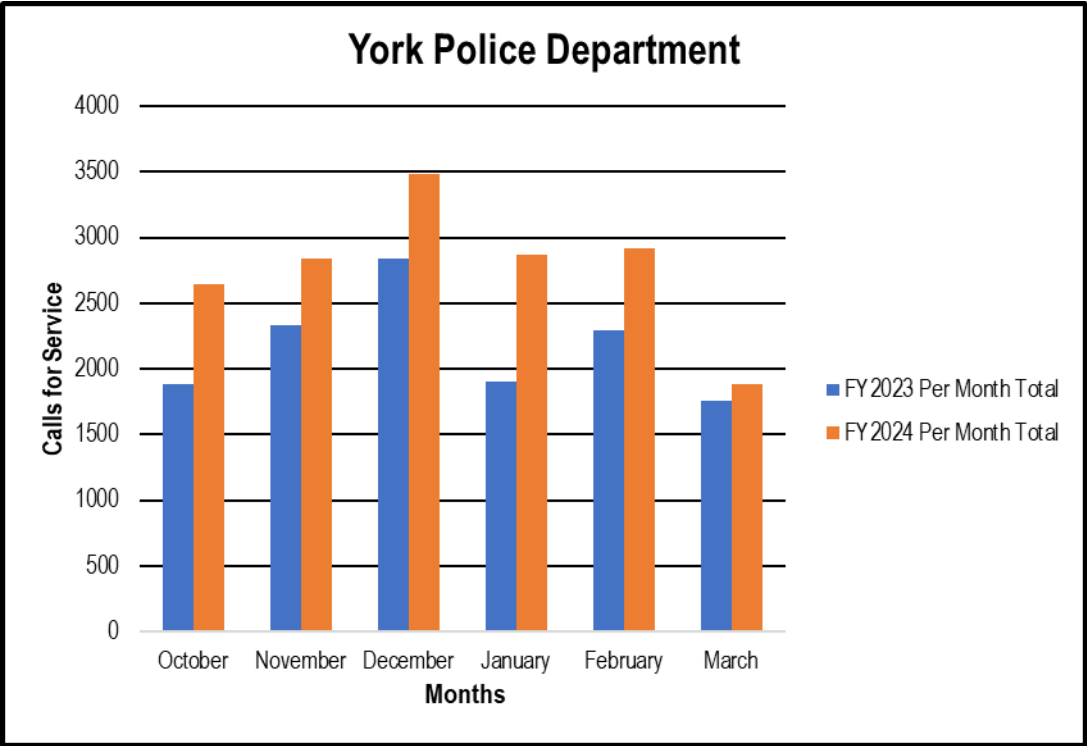
Data metrics can be shared through visualizations and graphs and communicated to teams through real-time alerting.

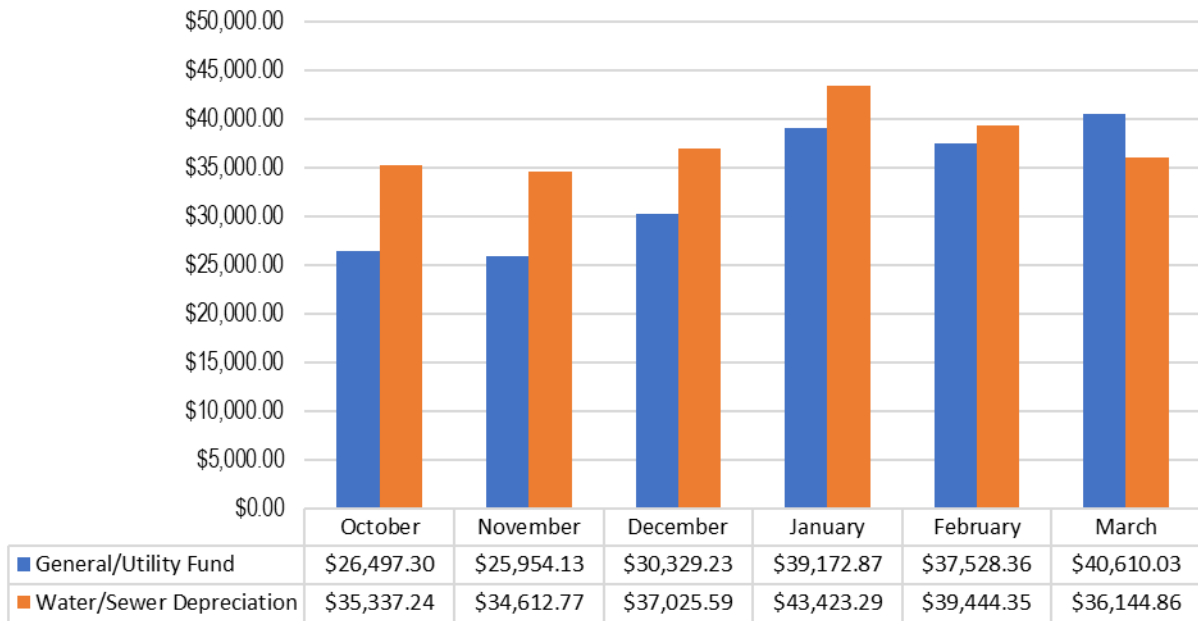
